Important Questions	Answers	Why This Matters:
What is the overall <a href="#">deductible</a> ?	\$3,000 individual / \$6,000 family.  <a href="#">Co-insurance</a> and <a href="#">co-payments</a> do not apply to the <a href="#">deductible</a> . This benefit combines your prescription drug and medical <a href="#">deductibles</a> .	Generally, you must pay all of the costs from providers up to the <a href="#">deductible</a> amount each <a href="#">plan</a> year before this <a href="#">plan</a> begins to pay. If you have other family members on the <a href="#">plan</a> , each family member must meet their own individual <a href="#">deductible</a> until the total amount of <a href="#">deductible</a> expenses paid by all family members meets the overall family <a href="#">deductible</a> . Your <a href="#">plan</a> year: 01/01/2019 through 12/31/2019.
Are there services covered before you meet your <a href="#">deductible</a> ?	Yes, <a href="#">preventive services</a> , generic wellness drugs	This <a href="#">plan</a> covers some items and services even if you haven't yet met the <a href="#">deductible</a> amount. But a <a href="#">co-payment</a> or <a href="#">co-insurance</a> may apply. What is the <a href="#">out-of-pocket limit</a> for this <a href="#">plan</a> ?	\$6,750 individual / \$13,500 family. Medical and prescription drug out-of-pocket limits are combined. <a href="#">Prescription drugs</a> : \$1,350 individual / \$2,700 family.	The <a href="#">out-of-pocket limit</a> is the most you could pay in a <a href="#">plan</a> year for covered services.
